







School and Community Teams

- New SEND 'Front-Door' – managing demand through effective triage and early support for both SEND & PEX
- Analysis of relative need 'vs' absolute need to determine parental expectations 'vs' parental confidence

Secondary Alternative Provision

• Managed Moves revised protocol led by LA to reduce PEX, building on evidence base that LA facilitated managed moves lead to sustained placement

Independent School Placements and Provision

 Targeted casework and 'marketing' for first refusal to parents of children in current independent schools to move to Good/Outstanding state funded provision ahead of aging out process

Specialist Provision SRBs and Special Schools

- School to School (S2S) outreach model from special school to mainstream, specialist partner outreach deployed at Zone level (complex needs) and countywide level (ASD/SEMH)
- Revised special school consultation model

Reducing flow of children into EHCP referral and clarifying parental / professional expectations for thresholds

Reducing PEX to enable re-modelled provision for SEMH to reduce independent placements Changing the flow of C&YP into independent and state-funded special to increase SRB and mainstream placement stability








Sensitivity analysis of special school referrals within DSG remodelling

- SV submission projected in-year break-even position during 2027/28
- Unexpected increase in special school referrals has the potential to continue the in-year deficit without further mitigations



- SV submission estimated for growth in unmitigated referrals of c. 100 pa for special school provision (based upon previous year's trends)
- Actual growth in referrals in 2022-23
 has been higher, resulting in a
 significant increase to the 'start point'
 for 2023-24 specialist places required
- We had not anticipated and modelled reducing demand at this point in the programme as projects take time to impact – but the base level of growth is higher than originally projected
- Additional projects now coming into the programme will be the mitigation to the position shown in the sensitivity analysis

The table shows those current 2024-25 projections as the proposed budget alongside the 2023-24 forecast, as at the end of November 2023, for comparison.
